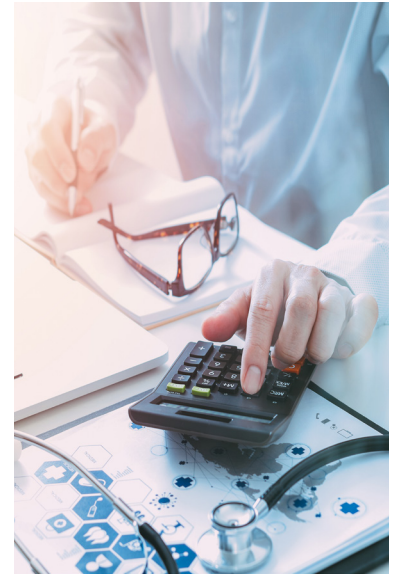

Class members include U.S. providers who provided healthcare services equipment or supplies to any patient who was covered under any of the Settling Individual Blue Plans during the Settlement Claims Period. Providers that have otherwise fully released their claims are not eligible.

- 92% of the fund is allocated to healthcare facilities (General Acute-Care Hospitals and Other Facilities)
- 8% of the fund is allocated to healthcare professionals
